Wholesaling & MLS Now Rules! Anne Petit, VP of Quality Assurance Executive Report

Recently MLS Now announced the addition to Rule 2.5 – Accuracy of Listing Data and Detail on Listings a falsification policy which

memorializes the requirement for listing agreements to be signed by the owner(s) of record or their lawfully authorized agent/representative.

This requirement speaks directly to the proliferation of wholesaling and attempts to include wholesale agreements in the MLS as real property listings. First, let's not assume everyone who holds an Ohio real estate license knows exactly what the wholesaling of real property is or entails...

Wholesaling real estate is a short-term business strategy in which a wholesaler acquires an assignable contract for the right to purchase a property from a seller. That property is usually in a distressed condition, owned by an elderly or recently widowed person(s) who feel some financial pressure or are just not able to maintain the property any longer.

In actuality, the goal is to sell the assignable contract to a third party for a profit with not much beyond time and marketing efforts involved for the wholesaler. Note that such an arrangement does not say that the wholesaler is going to close on the property. Typically, the wholesaler provides a small – or no – earnest money deposit to the seller and does not take title to the property. The assignable contract sets out the price (to the homeowner seller) and a specific period of time during which the wholesaler will attempt to find an end buyer.

To be clear, the marketing of an assignable contract is legal in Ohio. HOW that contract is marketed is the key to whether it crosses Ohio license

law lines, although that ultimate determination can only be made by the Superintendent and Ohio Real Estate Commission. By their very nature, though, assignable contracts do not represent real property and therefore cannot be marketed as such. The only permissible way to market a wholesaling contract is to provide that an assignable contract is available for sale.

What does that mean for every licensed real estate professional in Ohio, especially MLS Now members under our rules? Currently, it means that a property subject to a wholesale agreement, or assignable contract, is probably crossing that line if photos of the property, its physical address, and/or descriptions of the property are used in marketing. Ultimately and for MLS Now's purposes, it means it is not a listing permitted in the MLS Now system.

Please note that a work group formed by Ohio REALTORS® has been studying this issue for the past year or so. That group is currently reviewing draft language that would regulate the practice of wholesaling by requiring either real estate licensure or registration with the Division and, in both cases, Division-promulgated disclosures to property owners and potential buyers of the assignable contract.






MLS NOW MARKET STATS AUGUST 2023 HIGHLIGHTS


Sales Price





MLS Now Membership Feature Article: Member ID or License Number?



I'm confused! Is it my MLS Member ID or my license number?

When signing into MLS Now, you may think that you are using your license number and, in most cases, we currently assign your license number as your MLS Member ID but...it is still only your MLS Member ID.

It is the responsibility of each agent to ensure during a transaction that their current license number is used on documentation and not their MLS Member ID. To help lessen any confusion, we are working on getting the MLS Member ID and the current license number to display on listings and applicable reports. We hope to have this available before the end of the year.

In the meantime, license numbers for Ohio licensees can be found on the <u>Ohio Division of Real Estate Center, ODRE</u>. License numbers for West Virginia licensees can be found on the <u>Real Estate Licensee Database, ARELLO</u>. To ensure the most current license number is being used, please start practicing this way of looking up an agent's license.


In other news regarding MLS Now's Member IDs, starting in January 2024, we will be moving from using the license number to an MLS Now membership system-generated Member ID. This will only be for licensed brokers, agents, appraisers, and support staff who have never had an assigned Member ID in our database.

Anyone added before January 2024 will continue using their current MLS Member ID. If an agent's license number changes with the ODRE or the West Virginia Commission, then MLS Now needs to be notified so we can update the primary license number field on the MLS Now account. This will not change the MLS Member ID. For those persons previously assigned an MLS Member ID, please make sure that you use their existing MLS Member ID when adding them to your roster. This will ensure that all their off-market listings, saved searches, contacts, etc., stay attached to their account.




