The purpose of a UPA for a real estate agent is to grant them access to enter and modify listings for agents who have input capabilities, as well as to conduct searches. The purpose of a UPA for an appraiser is to grant them access to run searches or give the MLS Now Appraiser Participant the option to add their licensed appraiser assistants.

The following cannot be added as UPAs:

- 1.) Out-of-state or Ohio licensed agents or appraisers.
- 2.) Agents licensed with a referral or holding company.
- 3.) Licensees showing suspended with the State.
- 4.) Unlicensed persons working for investors, builders, mortgage companies, title companies, or any other real estate-related business.
